In case the requirement of passing IMM has not been introduced in your subject, old rules will apply for validity of FCPS-I and for registration with R&RC. In that case, you must appear at least once in the final FCPS Part-II examination before the expiry of three years plus the duration of training in the chosen speciality, failing which this FCPS Part-I result will become null and void.

Please note that requirements of training are constantly under review and it is your responsibility to be aware of the current regulations, which will be applicable to you, on the date of registration. **FCPS-I** is **NOT** an academic qualification and you are not authorized to write it along with your other degrees/diplomas on your letterhead, visiting card, signboard, nameplate, etc.
